Our News

Special Lectures

Division for Graduate Studies organises special lectures by eminent academicians from the field of Social Sciences every month for the benefit of research scholars pursuing Ph.D at CESS. This was initiated in 2021.

- ⇒ Prof. Kaliappa Kalirajan, Crawford School of Public Policy, The Australian National University, delivered a special lecture titled "Whether India has achieved its Potential Efficiency in Merchandise Exports?" on 24 Feb, 2021. The lecture intended to present the empirical framework with the application of Stochastic Frontier Method in international trade, which was earlier in Production Economics. The current scenario in India shows that the service sector is on the verge of saturation and unemployment reaching a 45-year-old high in 2019 at 7.8 per cent. He suggested that India needs to focus on manufacturing sector in order to create jobs, and to attract FDI and improve the technology, which will lead to economic growth. Upgradations like the Nehru Port should be followed in each of India's major ports. The Government can make the credit system for export sector as a priority sector lending, and can include this sector under Corporate Social Responsibility.
- ⇒ Prof. Rahul Mukherji, Heidelberg University, Germany delivered a special lecture titled "Policy Paradigms, Paths and Change" on 24 May, 2021. The lecture discussed about how policy paradigms impact governance. He also presented few conceptual ideas which were studied by historical institutionalists. The lecture has given a clear understanding about layering, drift and displacement and explained about what happens when a policy paradigm changes with examples.
- ⇒ Prof. K. Srinath Reddy delivered a special lecture on topic "The Road to Universe Health Coverage" on 29 June, 2021. His lecture highlighted the details of government policies for health care and the measures to be taken for effective health care.
- ⇒ Prof. Sunil Mani, Director of Centre for Development Studies, Trivandrum, Kerala delivered a special lecture on 28 July, 2021 on "The role of industrial policy in market-friendly economies-case of COVID-19 vaccine R&D and its manufacturing in India and the USA". Prof. Sunil Mani in his lecture covered mostly about the theoretical proposition in innovation of Economics, which talks about market failure in knowledge production, calling for government



- intervention. He described the policy instruments which deals with market failures. And explained the role of policy instruments in research and development with the scenario of India and U.S.A.
- ⇒ Special lecture on "Local Self-Government, Decentralisation and Women Empowerment" was conducted for the second semester scholars by Shri. S.M. Vijayanad IAS (Retd.) on 7 July 2021 as part of the paper on India's Development Debate. The lecture began by tracing the evolution of local self-governments in the country focusing on the 73rd and 74th Amendments. The lecture discussed the growth, development and



funding process of local governance institutions. The speaker further talked about the problems faced by the Panchayati Raj Institutions (PRIs) in India. He further examined the need for local self-governments to improve their resource raising capacity. He compared the performances of different local self-governments in various states based on the Devolution Index. The speaker also noted that about 50 to 60% of Women and Child Development Plans work under the local self-governments, indicating the importance of PRIs in women empowerment. The speaker also discussed the crucial role of local self-governments in disaster management, by citing the performance of PRIs in controlling the spread of the Co-Vid 19 pandemic. The lecture was followed by a fruitful discussion by the discussant and scholars on the questions that were sent prior to the speaker.

⇒ Special lecture on 'Post-independence India: A Socio-Political Critique' was conducted for the second semester scholars by Prof.M. Kunhaman (TISS) on 15 and 16 July 2021 as part of the paper on India's Development Debate. Prof. Kunhaman has begun his lecture by discussing different development perspectives during pre and post-independence. He discussed at length, the Gandhian Perspective, the Nehruvian Perspective, Ambedkar's idea of development and the Communist Perspective of Development. The speaker also examined the importance of Planning for the economic and societal development of the country. Prof Kunhaman made a detailed analysis of various Five-Year Plans in the country and discussed how objectives were framed and achieved in each plan. He also talked about how planning became a mere bureaucratic practice and lacked the involvement of people in it. The speaker also discussed about the Hindu Rate of Growth and land reforms in the country. Prof Kunhaman also pointed out the failure of Farmer's Organizations and political parties in taking up the issue of landlessness. He also mentioned about the positive and ill-effects of Green Revolution. He concluded the lecture by asserting the need for an inclusive development where there is equitable distribution of resources. It was indeed a very thought-provoking lecture.

Round Table Discussion on Union Budget

Round Table Discussion on Union Budget 2021 Analysis was conducted on 19 February, 2021. Faculty members and Research scholars have participated and presented on various dimensions such as Industry, Agriculture, Service Sector, Water, Sanitation and Clean Air, Food Security, Health, Rural Development, Malnutrition and inequalities. The discussion highlighted the paradigm shift that took place from 1991 budget to the present highlighting the importance of Liberalisation, Privatisation and Globalisation in the economy. The concern was also about the raising inequalities, different tax reforms, tariff policy reforms, structural reforms in agriculture and also the impact of covid-19 pandemic on the agriculture sector due to the reverse migration. In addition, budget 2021 focused more on the development of Micro, small and medium

enterprises by providing Emergency Credit Guarantee Scheme for credit assistance. The budget also highlighted the financial reforms in banking and insurance sector.

Women's Day Special Lecture

► The session was conducted on the eve of International Women's Day on the topic "Women's Entitlements to Land: The Question of Norms and Attitudes" by Govind Kelkar on 8th of March 2021, at CESS. The session was chaired by Prof. E. Revathi, Director, CESS and moderated by Dr.T.S. Jeena.



Prof. Kelkar in her presentation showcased the gender regime in Asia: Women in the struggle for equality. The whole session revolved around how women enable themselves by the state policies to claim their right to land and what impact the struggle for land ownership have had on the economic agency of women. Prof. Kelkar covered a wide range of issues including poverty, gender, inequality, social cultural justifications especially those prevailing in Asia and legal rights and constraints of land and property rights.

Doctoral Committee (DC) Meetings

The Doctoral Committee Meetings will be held every year twice. The purpose of these DC meetings is to assist the research scholar in finalising their proposals and in the consecutive meetings, the DC member would review the progress of the concerned research scholar. The Supervisor and the Dean, DGS would be part of these meetings. Each research scholar may have one or two DC members along with the supervisors.
