

He provided a reflective message, focusing on the Challenging Journey of pursuing a Ph.D. He emphasized the need for passion in research, urging students to be dedicated to reading and hard work while ensuring their research is socially relevant.





Statistical Analysis Training

A four-day intensive STATA workshop was conducted from September 3-6, 2024, under the guidance of Prof. C. Ravi and Mr.Jadhav Chakradhar. The workshop equipped participants with essential quantitative research tools and practical applications using real datasets. This training program strengthened scholars' capabilities in statistical analysis and data management, reinforcing CESS's commitment to research excellence through hands-on training in advanced research methodologies.

Round Table Discussion on Union and State Budgets 2024-25

The Division for Graduate Studies organized a session on Budget Analysis on August 6, 2024, examining the Union and State Budgets 2024-25. The presentations covered Income Tax & Corporate Tax, Minority Affairs, Energy, Women Empowerment, Agriculture at national and state levels, Environment, Health, and External Affairs. The discussion was enriched by valuable insights from the panel members, leading to a comprehensive examination of fiscal priorities and their implications for development.

Panel Discussion on 'Economic and Political Milestones in India's Growth Story'

The Division for Graduate Studies organized a panel discussion on 'Economic and Political Milestones in India's Growth Story' as part of the curriculum on India's development debate. The discussion explored three critical themes: India's growth story through an economic lens, the growth of the manufacturing sector and catch-up of the service sector, and the political dimension of India's fading manufacturing sector. Faculty members have enriched the discourse with their insights during the post-presentation discussion, contributing to a comprehensive understanding of India's growth narrative.



Special Lectures

Special Lecture on 'Stabilisation policy options in a 'Lower and Longer' (L&L) interest rates environment

Chairman Prof. Dilip M. Nachane's lecture on April 29, 2024, explored stabilization policies during periods of prolonged low interest rates. He discussed three main approaches to tackle the Zero Lower Bound Interest Rate (ZLB): overcoming ZLB through mechanisms like taxation and dual currency systems, addressing the Keynesian liquidity trap through inflation targeting and fiscal stimulus, and managing credit deadlock through Quantitative Easing (QE). The lecture highlighted Hawtrey's pioneering contributions to QE theory, which modern economists have primarily overlooked. Prof. Nachane emphasized that economic ideas never become obsolete, and current policy improvements must build upon historical knowledge and understanding of monetary theory.



Special Lecture on 'Transformative Urbanisation Towards India 2047'

CESS's Division for Graduate Studies hosted a special lecture by Prof. Jyoti Chandiramani on transformative urbanization, chaired by Prof. E. Revathi, on November 14, 2024. The lecture explored cities as drivers of economic growth, addressing urban poverty, infrastructure needs, and sustainable development. Prof. Chandiramani discussed global urban trends, citing examples from Pune's water management and South Korea's smart city development. Drawing from Nobel laureate Paul Romer's "Making Room" approach and Jane Jacobs' insights, she emphasized that cities contribute 80% of global GDP. The lecture concluded by stressing urgent urban planning needs for 2047, noting that 68% of the world's population will live in urban areas by 2050.



Special Lecture on 'Urban Turn: Contest and Contestation'

The Division for Graduate Studies at CESS hosted a special lecture by Prof. Sudha Mohan, Former Professor and Head of the Department of Civics and Politics, University of Mumbai, on December 11, 2024. The lecture explored India's urbanization challenges, chaired by Prof. E. Revathi and introduced by Dr. Alivelu Kasturi. Prof. Mohan analyzed the development patterns of historically significant cities while addressing contemporary urban governance issues, particularly in megacities post-COVID-19. Drawing comparisons with China's distributed development model, she advocated for strengthening small and medium towns to reduce metropolitan pressures. The lecture concluded by emphasizing the importance of decentralized governance and creative solutions for sustainable urban development that maintains harmony between rural and urban spaces.



Special Lecture on 'Seed Industry in India: Current Challenges'

The Division for Graduate Studies at CESS hosted a lecture on "Seed Industry in India: Current Challenges" on December 17, 2024, featuring Mr. Manish Kushwaha and Mr. Mayank Kushwaha, with Mr. K. Sudheer from Canada as facilitators. Chaired by Prof. E. Revathi, the lecture explored critical challenges in India's seed industry, emphasizing the role of hybrid seeds in productivity and food security. Mr Manish Kushwaha discussed the advantages of open-pollinated seeds for biodiversity conservation and food sovereignty while contrasting them with hybrid seeds. Mr Mayank Kushwaha shared his transition from a technologist to a seed enthusiast, focusing on preserving biodiversity and promoting sustainable agriculture in Telangana and Uttar Pradesh. The session concluded with Dr Alivelu Kasturi highlighting urban farming solutions, emphasizing the need for sustainable approaches in both rural and urban contexts.



OUR ACTIVITIES

Ink and Insights Society

CESS launched its book club "Ink and Insights Society" in February 2024, marking a new chapter in the institute's intellectual pursuits. Named through a competition won by PhD scholar Vinitha Anna John, the club began its journey with Chimamanda Ngozi Adichie's "Dear Ijeawele" exploring feminist perspectives and gender narratives. The inaugural meeting at BPR Vithal Auditorium on February 23 set the stage for meaningful literary discussions.

The club's activities expanded beyond regular book discussions to include special events marking significant occasions. For International Women's Day, members explored the evolution of gender discourse, drawing parallels between Tarabai Shinde's 1882 work "Stri-Purush Tulana" and contemporary feminist literature. Independence Day was commemorated with a poetry competition on "Freedom at Midnight" with joint winners Vinitha Anna John and Suadath V.

Through its carefully curated reading selections and inclusive discussions, the Ink and Insights Society has emerged as a vibrant platform fostering intellectual exchange and literary appreciation within the CESS community.
