

From the Director's Desk....

The six-month period from October to March witnessed good academic activity. It was the season of seminars and conferences as well as completion of research projects. Select papers presented at the 22nd IASSI Conference hosted by us in November 2023, have been brought out as

an edited book published by Springer titled 'Intersecting paths of Sustainable Development, Urbanisation and Women's Empowerment', which was released in the 23rd IASSI Conference held in IIT Ranchi, in November 2024. A second book was published by one of the faculty on 'Gulf Migration and Rural Transformation in Telangana'. Faculty have published 6 book chapters and 15 research papers in journals. Couple of studies have been completed on school education-social audit of PM POSHAN and Sarva Shiksha Abhiyan. Research scholars have presented their research progress to the doctoral committees held in the November-December window. Research scholars also organised annual sports and cultural events culminating in the Cultural Day on 31st January 2025.

A collaborative project has been launched in December on 'Doing Research in India: Assessing Social Science Research' awarded by the ICSSR and Global Development Network. Two other new research projects in agriculture, focusing on natural farming practices have been launched – one on Andhra Pradesh Community Natural Farming – Verification Survey, and the second on Fertilizer Consumption, Costs and Returns from Agriculture in Andhra Pradesh, awarded

by Rythu Sadhikara Samastha (RySS), Government of Andhra Pradesh. Phase - II school survey has been taken up on the Assessment of PM POSHAN Program in the state of Telangana 2024-25, 2025-26 and 2026-27 (Phase-II), funded by Department of School Education, Government of Telangana. In the realm of Public Finance, a couple of studies have begun - Evaluation of State Finances for the State of Andhra Pradesh awarded by the 16th Finance Commission, and A Situational Analysis of the Financial Status of the PRIs in Telangana State in the Context of II SFC awarded by the State Finance Commission.

The Govt. of Telangana has taken up a Comprehensive Door to Door Household Survey - Socio, Economic, Educational, Employment, Political and Caste Survey, in November-December 2024. Our Centre was involved by the Planning Department, Govt. of Telangana in analysing the data. Faculty, scholars and staff have toiled for two months to analyse the data and a team of faculty has prepared the Analytical Report of the TGSEEEPC survey which was submitted in March 2025. This was well appreciated which served as a base report and further analysis was taken up by a dedicated committee appointed by the Govt. of Telangana. The Centre has organised the 3rd Annual BPR Vithal Memorial Lecture given by Dr D Subba Rao on 30th January; 7th Foundation Day Lecture given by Prof Santosh Mehrotra on 6th of March 2025. Current batch PhD scholars presented a review on 'India Gender Report 2024' on the occasion of Women's Day on 8th March 2025. The Young Lives- India Factsheets released in New Delhi in March 2025 has drawn a good response and discussion. Fact sheets for the two states of Andhra Pradesh and Telangana are under preparation.

Completed Studies

 End Line Elections Survey of Knowledge, Attitude and Practices (KAP) of Citizens in Telangana State (Sponsor: Chief Electoral Officer, Telangana State; Project Team: M. Gopinath Reddy, B. Suresh Reddy) The specific objectives are:

- i) To understand the level of Knowledge and Awareness of Voters about various issues of Election and their participation in Election Process.
- ii) To gauge the attitude (willingness) of voters towards Registration as Voter and participation in Voting Processes and the key determinants of attitudinal changes of the Voters on these issues.
- iii) To understand the level of participation of voters in process of Registration, Enrolment in the recently concluded 2024 Parliamentary Elections.
- iv) To understand the takeaways of the campaigns for Voter awareness and education and various other initiatives launched in the Telangana State by the CEO, Telangana.
- 2. A Situational Analysis of the Financial Status of the PRIs in Telangana State in the Context of IInd SFC (Sponsor: Telangana State Finance Commission, Government of Telangana; Project Team: M. Gopinath Reddy)

The main objective of this research is to understand the finances of the PRIs in the state of Telangana in the context of institutionalisation of the Second State Finance Commission (FSFC) in the state. Further, it is to understand that how the issues of Finances of the PRIs have been taken up by the State Government in the state and what are the overall implications of this process on making PRIs effective and viable for delivering goods and services. It is also intended to understand the finances of the state and the status of OSR of the state. The main source of this research and its objective is based on the formation of the IInd SFC in the state and emerging issues of the finances of the state and how it will influence the finances of the PRIs of the state.

3. Performance Evaluation of Farmer Producer Organizations (FPOs) in Telangana and Andhra Pradesh (Sponsor: Small Farmers Agri Business Consortium (SFAC); Project Team: Arifa Sultana)

The project was assigned by SFAC, Delhi to analyse the performance of FPOs under the Central Sector Scheme



Formation and Promotion of 10,000 FPOs. 24 FPOs of Telangana and 6 FPOs from Andhra Pradesh were evaluated. The various indicators on which the FPOs were evaluated included governance, compliance and capacity building, equity grant, FPO input and output business, marketing, business planning, turnover of FPOs, and best practices were analysed. The report was submitted to SFAC, Delhi.

4. Socio-Economic and Heritage Impact Assessment Study for Assessing the Impact of Proposed PVNR OCP and KTK OC-III Exp. on Ramappa Temple. (Sponsor: The Singareni Collieries Co Ltd., Government of Telangana; Project team: Anjaneyulu, Parupally, Bharat Bhushan M, Venkatanarayana M.)

Telangana State's Mulugu and Bhupalpally districts are well-known for their scenic locations and expansive coal mines. Several opencast and underground mining projects are under operation by The Singareni Collieries Company Ltd (SCCL) in both districts. The PVNR Open Cast Mining (Venkatapur village) situated around 5 km from Ramappa Temple and KTK OC III Exp mining project (Baswarajpally village) situated around 8 km from the temple are proposed to be launched shortly by the SCCL. The Palampet Special Development Authority (PSDA) recommended conducting a socio-economic and cultural study to assess the impact of the proposed mining projects on universal value, biodiversity and the safety of the temple and ecology. In light of this, the SCCL Corporate Environment Department commissioned

the Centre for Economic and Social Studies (CESS) to carry out a socio-economic assessment and determine how the proposed expansion project would affect the socio-religious attachment of the local population to Ramappa Temple, biodiversity, and heritage.

The methodology of the assessment comprised a blend of quantitative and qualitative methods that encompass both primary and secondary data sources. Structured schedules for capturing data from the sample households and in-depth interactions with key stakeholders (priests, community/village elders, elected officials from the study area, SCCL project authorities, research scholars, and specialists in the domains of social and environmental impacts of development projects) were employed to gather the required data and insights. The study sample of 1,200 households represent 40 villages-24 from the core regions and 16 from the buffer zones—with each sample location representing 30 households. The report submitted to the sponsoring agency contains the findings and recommendations of the assessment.

1. Development Initiatives for transforming the socioeconomic status of Marginalised Communities in Andhra Pradesh State-Impact of TSP and SCSP (Sponsor: ICSSR, New Delhi; Project Team: M. Gopinath Reddy)

The broad objective of the study is to examine the process of socio-economic transformation that has been taken place in the context of implementation of the TSP and the SCSP in the states of Andhra Pradesh and Telangana. Further, it is intended to explore how the implementations of these programmes have impacted on quality of life of these communities as a part of economic transformation. Further, it is intended to explore the processes of implementation of these programmes and the ways these programmes have brought change in the socio-economic conditions of the STs and SCs in the state.

Considering the broad objective, the specific objectives are; (i) to examine working of TSP and



SCSP in the states since the enactment of the SCSP and the TSP Act, 2013, (ii) to examine the pattern and trends in transferring funds under these two programmes from the State Government and (iii) to explore the implementation of various development programmes under TSP and SCSP and (iv) impact of these programmes on promoting socio-economic transformation of the STs and the SCs in the states. v) To suggest few policies relevant recommendations to strengthen the implementation of SCCP/TSP.

 Assessment of PM POSHAN Program in the state of Telangana 2024-25 (Sponsor: Government of Telangana; Project Team: E. Revathi, Jadhav Chakradhar, C. Ravi, P. Prudhvikar Reddy, Bharat Bhushan)

Upon the satisfaction of the report submitted by the CESS on the Social Audit of PM POSHAN – Phase-1, the government of Telangana entrusted our institute to undertake the social audit of PM POSHAN – Phase-2, and the process started in December 2024. A two-day training session for field investigators was conducted on 17th and 18th January 2025 in CESS. Senior officers from the government also participated and gave their input to the trainees. Fieldwork commenced immediately after the training and was completed in March 2025. Data cleaning and entry started in the second week of February 2025 and will be completed in the first week of April 2025. The final report of the study is expected to be in May 2025. The social audit process adopted mixed methods for data collection. A systematic sampling procedure was adopted while

selecting 690 schools from all the districts, including all categories of schools, government, and government-aided schools were considered. As per the mandate, a minimum of 20 schools from each district were studied.

3. Young Lives Survey- Improved understanding of the causes and effects of childhood poverty, inequality, and education – Young Lives at Work – Seventh Round (Sponsor: Department for International Development (DFID), Oxford, UK through Oxford University; Project Team: E. Revathi, P. Prudhvikar Reddy)

Young Lives is a longitudinal study of poverty and inequality. It completed its round-7 survey in Telugu states that had produced fact sheets on Education and Learning, Health, Nutrition and Well-Being, and Work and Family Lives. Dr. Shamika Ravi, a Member of the Economic Advisory Council for the Prime Minister, released the fact sheets on 20th March 2025 at the

India Habitat Centre, New Delhi. She underscored the importance of evidence based studies for effective policy making.

4. Field Verification of Various Components under Andhra Pradesh Community Natural Farming Under RySS (Sponsor: Government of Andhra Pradesh; Project leader: Y.Sreenivasulu)

This study aims to critically assess the ground-level implementation and outcomes of the Andhra Pradesh Community-Managed Natural Farming (APCNF) initiative, with a particular focus on verifying the



practices adopted by farmers and evaluating their alignment with the data maintained by Rythu Sadhikara Samstha (RySS). In addition to validating the reliability of the URVI database, the study seeks to facilitate structured dialogues among Community Natural Farming (CNF) farmers and key stakeholders—such as PMDS (Pre-Monsoon Dry Sowing) farmers, Village Organizations (VOs), Self-Help Groups (SHGs), SHG members, Non-Pesticide Management (NPM) shop operators, Internal Community Resource Persons (ICRPs), and other associated entities—towards evaluating the progress, identifying challenges, and deliberating on key issues concerning APCNF. Field visits to farmers' plots form a core component of the study, enabling the research team to directly observe natural farming practices, including the extent of adoption, use of chemical fertilizers and pesticides, and the continuation of PMDS farmers into S2S (Seed-to-Seed) practices in subsequent seasons. A mixed-methods research design, incorporating both qualitative and quantitative approaches, has been adopted to facilitate a comprehensive and evidencebased evaluation of the APCNF initiative. This methodological pluralism ensures the triangulation of findings, thereby enhancing the depth, accuracy, and credibility of the study outcomes.

The DRA project was launched in December 2024 in ICSSR, New Delhi. The project aims to assess the state of social science research in India by evaluating its production, diffusion, and uptake through a globally standardized methodology. The assessment will unfold in four key phases: context analysis, stakeholder

mapping, framework-based data collection, and national-level dissemination.

The DRA will produce an in-depth analysis of India's research ecosystem, map key actors, generate a dataset based on 54 global indicators, and deliver a comprehensive 3-part report. It aims to inform policy, strengthen research capacity, and enhance evidence-based development planning. GDN will provide technical support and ensure alignment with international standards, while leveraging its global network to give visibility to India's assessment. The DRA in India is part of a broader rollout across Asia, including Cambodia, Laos and Fiji started in 2024.

2. Breaking Glass Ceilings at Workplace: Empowering Women Entrepreneurs in the MSMEs Sector of South India (Sponsor: Special call for Collaborative Research Projects on Vision Viksit Bharat@2047, ICSSR, New Delhi; Project Team: Y. Kesava Reddy, Brajaraja Mishra, Sushanta Kumar Mahapatra, M. Srinivasa Reddy and Neeraj Kumar)

This multidisciplinary and evidence-based research proposed study outlines a comprehensive study aimed at breaking the invisible barriers hindering the success of women entrepreneurs in the Micro, Small, and Medium Enterprises (MSME) sector in South India. This study will focus on all five South Indian states—Andhra Pradesh, Karnataka, Kerala, Tamil Nadu, and Telangana—due to their vibrant MSME sector and the growing presence of women entrepreneurs. The



selection of this region allows for a comprehensive exploration of the challenges and opportunities faced by women entrepreneurs across diverse sectors and settings. The research will address several gaps in existing literature, including the underexplored area of invisible barriers faced by women entrepreneurs, the underrepresentation of women in MSME sector studies, and the lack of intersectional analysis. By employing innovative research methods such as a mixed-methods approach, thematic analysis, and statistical and econometric analysis, the study aims to generate new knowledge and insights into the experiences of women entrepreneurs.


