Our News

Special Lectures

Division for Graduate Studies organises special lectures by eminent academicians for the benefit of Research Scholars Pursuing Ph.D at CESS. This was initiated in 2021

- ▶ Prof. Jan Breman, delivered a special lecture titled “The Regime of Informality”, on 30 August 2021. The lecture intended to present the need to conceptualize Informal Economy or Informal Sector from various dimensions through the various disciplines of Social Sciences. The lecture started by discussing the vastness of Informal Economy and he called it “The Regime of Informality” instead of addressing it as a sector. Informality is a key subject for study and it is studied by every discipline of Social Sciences. And analysing it from the various dimension of social sciences is important to understand “What is Informality?” At the very first, Informality is conceptualized as a sector that is unincorporated like those economic activities which are not accounted. In, 2003 further ILO has redefined it as a sector of employment that works without any social security. The speaker has criticized this particular kind of definition of Informality which is tautological in nature. In his view, Informality is an outcome of the earlier development of the capitalistic mode of production around the nineteenth century.

In this new mode of production, the formalization process was introduced to decrease the plight of the workers class by organizing them, through introducing labour legislation for decent employment, decent payment, decent working condition and decent condition of living.

- ▶ Prof. Hans-Bernd Schaefer, discussed about Angus Maddison's work on long-term global growth statistics. Where he notes, the per-capita income during the time period 1000 years ago, 1500 years ago and later on. He presented that the per capita incomes of China and India about 1000 years ago was higher compared to total Western Europe. But during the time period 1000-1500 years the per capita incomes of Western European countries doubled compared to the rest of the world. The per capital incomes of East Asia and South Asia starting from 1820s to the first half of the 20th century is very less compared to rest of the world. While showing the fluctuations in global growth rates, he emphasized about the commercial revolution in Western Europe where evolution of rule of law and legal norms contributed for the development of the Western countries and off shores. Also discussed about the importance of legal innovations in Middle Ages to overcome the risks and to scale-up the economies, where he gave the examples of conversion of commons to private property abolishment of serfdom and share cropping by French Revolution which are causing under investments.
- ▶ Prof. U. Vindhya, gave lecture on Gender Sensitivity to Faculty, PhD Students, Research and Office Staff, on 15th September 2021. She narrated the gender sensitivity issues by complementing with live examples. She also emphasized on the congenial atmosphere in the institutions while giving space and mutual respect to all working in the institutions
- ▶ Prof. Kunal Sen, Director of the United Nations University, Institute World Institute for Development Economics Research delivered a special lecture on

“Covid-19 and Livelihood in the Global South with Specific Reference to India”. The lecture focused on the evolution of the pandemic, government responses and effects of pandemic on global poverty as well as on livelihoods. The speaker gave an example of a city, Hrishipara in Bangladesh, further explaining that the poverty in the city as well as head-count ratio has increased as a result of pandemic. The speaker also mentioned that India in its policy response spent 20 trillion rupees as fiscal stimulus, while giving subsidized food grains and providing employment through MNREGA. The speaker concluded the lecture by saying that, the pandemic has had large negative effects on livelihoods and jobs in the global south, while informal sector was affected the most

- ▶ Prof. Prakash Sarangi, Former Vice-Chancellor, Ravenshaw University, delivered a CESS-DGS special lecture “Welfare Discourses in India” on 20th December, 2021. The lecture mainly highlighted the change that is happening now based on the history of welfare policies. It also focused on trends in welfare discourses since independence. Besides discussing the symbiotic relationship between social development and economic growth, the lecture also focused on the four phases of welfare strategies adopted by government of India in depth.

- ▶ Prof. Nagesh Kumar, Director ISID, New Delhi, delivered lecture on: “Strategic Interventions for

Industrial Transformation of India: Lessons from Experiences of Industrialized and East Asia Countries”. Prof. Nagesh Kumar focused on transforming Asia from its status of the most impoverished region to the growth hub of the world within the past five decades. The speaker observed that the East Asian countries majorly drove transformation. East Asian countries have experienced dramatic and unprecedented growth, industrial transformation, and socio-economic progress in the last five decades, a lesson for latecomers like India. The foremost reason behind the success of the East Asian countries like Japan, Taiwan, Singapore, Thailand, Malaysia, and China followed the classical pattern of structural transformation from agriculture through manufacturing or industry. On the contrary, India experienced a jump in this process as it directly moved from agriculture to the service sector, bypassing the manufacturing sector.
